Subject Partner Update: COVID-19 Service Updates & Connecting with Our Team

COVID-19 Service Delivery Update

AMHS-KFLA services are all fully open and remain accessible, including in-person services where needed to support client needs and care.

Referrals to our programs continue to be accepted and are conducted over the phone. Partners are invited to use our online professional referral form, as well as usual channels, to submit a referral.

During the pandemic period, a "virtual" care environment has also been created to support delivery of services to some clients while assisting in keeping our community safe. This service innovation has changed the way we interact with our clients and will likely be a part of our service delivery model for the foreseeable future.

Services Continue: Staff and Services Remain Accessible to Clients and Partners

- Main reception phone lines remain open and functional during usual business hours.
- Crisis Services continue (mobile services, 24/7 Crisis Line, etc.), with the <u>exception of walk-in</u> crisis services.
- All clients maintain access to staff.
- As shared, referrals to our programs continue to be accepted and are conducted over the phone.
 Partners are invited to use our <u>online professional referral form</u>, as well as usual channels, to submit a referral.
- Care appointments for the following services are provided remotely (e.g., by phone, OTN, etc.) or in-person in the community to better support physical distancing and support or prevent crisis situations:
 - o Counselling & Treatment
 - Case Management
 - Justice Services (community-based, in-person supports available)
- All residential housing programs including Regional Safe Bed, Comprehensive Integrated (CI)
 Housing, Alternate Level of Care (ALC) Services and the Transitional Rehabilitative Housing
 Program (THRP) remain open and operating as usual;
- Assertive Community Treatment Teams (ACTT) services continue to offer face-to-face supports;
- Mobile Crisis response continues routine operations, the Mobile Crisis Rapid Response Team (MCRRT) partnership with Kingston Police also operates as normal;

 Outreach Teams, in collaboration with Home Base Housing, continue to connect in-person with those most vulnerable in our community, including providing support at the new Integrated Services Hub in Kingston.

Restoring Access to On-Site, In-Person Services: A Phased Approach

In alignment with the Province of Ontario's phased re-opening plans, AMHS-KFLA has begun to gradually restore our on-site, in-person services.

In preparation for this, we have developed a number of policies and protocols, made adjustments to our physical spaces and obtained additional PPE and cleaning supplies to support our safe return to increased in-person services.

We will continue to offer virtual care to clients where appropriate and effective and have begun a phased approach to reopening agency offices, effective August 17th.

As part of this first phase:

- Our site at 70 Dundas St. in Napanee offers on site, in person services by appointment.
- Our 107 Wellington St. location in Kingston offers on site, in person services by appointment to Addictions clients.

Screening and other processes to support staff and client safety will be in place at all agency locations.

Plans are underway to support the safe reopening of our other sites in Kingston, Sharbot Lake, Verona and Amherstview, with more information to be shared as timelines are confirmed.

We continue to collaborate with local and regional health partners to ensure our processes are in alignment with the latest recommendations, including the ability to return quickly to our previous state of service delivery modifications should the need arise and there is a shift to the broader provincial or regional cross-sector reopening plans.

Support Groups: Creating New Pathways to Accessing Support

In-person support groups remain on hold, however note:

- Some groups, including Day Treatment and Relapse Prevention, are now being offered in a virtual care environment.
- The <u>Understanding Addiction support group is available via our website</u> as a self-guided program, with associated worksheets. Visit our website to learn more about this program and access the videos and other resources.
